INSTRUCTIONS:

PLEASE READ THE FOLLOWING INSTRUCTIONS CAREFULLY. DOMAINPEOPLE WILL NOT PROCESS INCOMPLETE OR INCORRECT FORMS. DOMAINPEOPLE MAY NOT CONTACT YOU TO INFORM YOU OF AN UNPROCESSED FORM. THIS FORM IS TO RESTORE THE DOMAIN NAME BELOW. IT IS YOUR RESPONSIBILITY TO CONTACT DOMAINPEOPLE TO REQUEST A STATUS UPDATE IF THE DOMAIN NAME IS NOT RESTORED WITHIN TWO DAYS OF SUBMITTING THIS FORM TO DOMAINPEOPLE AT THE EMAIL ADDRESS OR THE FAX NUMBER BELOW.

1. This form must be completed and signed by the Registrant of the domain name listed on the form.
2. This form must be signed by the domain Registrant (or authorized representative of the Registrant Company).
3. If the current Registrant is a company, attach this form to:
 - a. Current business license
 - b. Certificate of Incorporation along with recent utility bill on the name of the company
 - c. Notarized letter or affidavit on corporate letterhead stating that the person represents the company and is authorized to do so.
 - d. Certificate of dissolution (if the company no longer exists)
4. If the current Registrant is an individual, then a copy of valid government issued picture identification must be attached to the form.
5. The Registrant must CONFIRM the \$125.00 USD redemption fee
6. The information submitted in this form must be true, accurate, and complete.
7. The Payment for the restore and renewal fee must be successful before DomainPeople can restore the domain name.
8. This form must be sent and received by DomainPeople during business hours (from Monday to Friday 9 a.m. to 6 p.m. EST) within twenty-five days of the domain name being deleted from DomainPeople. If the form is received more than twenty-five days after the domain name was deleted, DomainPeople will not be able to restore the domain name.
